Vaccine Administration rates are reimbursed as follows:

- 1) \$10 administration fee for Medicare and Commercial per vaccine, not per component
- 2) Vaccines are reimbursed at the HealthCare Partners group purchasing rate plus 4% (for Medicare and Commercial)
- 3) \$15 administration fee for Medicaid per vaccine, not per component
- 4) Vaccines for eligible Medicaid members are provided free by New York State for physicians enrolled in New York State Vaccines Program
