The 2020 HealthCare Partners Provider Quality Incentive Program

HealthCare Partners (HCP) is pleased to announce the 2020 Provider Quality Incentive Program (QIP). The purpose of these incentives is to reward providers for excellence in providing high quality healthcare, for properly documenting that care in their patients' medical records, and for submitting the associated claim and encounter data.

2020 Medicare Advantage Incentive Program

To Qualify:

Providers must have a monthly minimum of 10 HCP Medicare Advantage members to participate (10 members monthly, averaged over the 2020 calendar year).

To Earn Incentive Bonus:

Providers must have a monthly average of \geq 10 HCP Medicare Advantage members and an average 2020 risk adjustment score of \geq 1.10 to receive the risk score based bonus, and a Star score of \geq 4 to receive a quality score based bonus.

Medicare Advantage Incentive Description

The 2020 HCP Provider QIP Medicare Advantage Risk Adjustment and Quality associated bonus consists of a per eligible member per year (PEMPY) bonus stratified by the average annual per member risk score and by the 2020 dates of service related average Medicare Advantage Star provider rating.^{1,2}

Component A: PEMPY Payment Stratified by Risk Score

A minimum average per eligible member risk score for calendar year 2020 of 1.10 is required to qualify for the bonus. The PEMPY bonus amount is increased for every 0.01 increase in the 2020 average per member risk score as reported by CMS.

Component B: PEMPY Additional Payment for the Respective Quality Score

A bonus for the provider's 2020 dates of service average cumulative Star rating for the measures listed below is paid <u>in addition</u> to the average per eligible member risk score bonus.

- 9. Diabetes Care: Kidney Disease Monitoring
- 10. Diabetes Care: Blood Sugar Controlled
- 11. Controlling Blood Pressure
- 12. Rheumatoid Arthritis Management
- 13. Statin Therapy for Patients with Diabetes
- 14. Statin Therapy for Patients with Cardiovascular Disease
- 15. Annual Flu Vaccination

Payout Timing:

These two incentive components will be paid separately to providers: A) within 90 days of CMS releasing the mid-year 2020 Medicare Advantage member risk scores expected in June 2021, and B) within 90 days of Stars measures results release expected in November 2021.

¹ Eligible Medicare Advantage HCP member months attributed to PCP; member must remain an eligible Medicare Advantage HCP member in the following calendar year for a minimum of one month.

² Provider must be under active contract on date of payment to be eligible.
